## RULES AND REGULATIONS

The following instructions are to be followed by you before filling the Application Form. Hence, you are requested to act upon according to it.

1. You are informed to keep enough copies of all the certificates before submitting the original certificates. Once Original certificates submitted will not be returned till the Admission is approved by the University / board.
2. You will require these certificates to apply for Scholarship/ Bank Loan/ Education Loan/Passport etc.
3. The students of both UG and PG courses, who are eligible for the Scholarship/ Fee Concession (All types of scholarships) are hereby informed that the Government of India has introduced the new scheme of Direct cash transfer to the students. Hence, students are hereby informed to open a Savings bank A/c. (Bank of Baroda, R.R. Institutions Extn Counter Branch) and Aadhar Card is Mandatory for availing the above benefits for the academic year 2025-26.
4. The PG Students (M Pharmacy) who are Eligible for GPAT Scholarship are required to open a Savings Bank A/c. in Savings bank A/c. (Bank of Baroda, R.R. Institutions Extn Counter Branch) in any branch and Aadhar Card is Mandatory. In case of students belongs to SC/ST Category are required to submit the Caste Certificate in English version only for availing the Direct Cash Transfer from AICTE
5. If the candidate has obtained 90% and above in the qualifying examination (10+2) Exam, then you are eligible for merit scholarship. For details, please log on to National Scholarship Portal.
6. If the candidate belongs to SC/ST category and selected the seat through Karnataka Examination authority (KEA), they must apply for Scholarship/Fee-reimbursement from Social Welfare Office / Director of Technical Education, Government of Karnataka with all the required document before prescribed date every year. Late application will not be accepted under any circumstances.
7. In case of Non-receipt of Scholarship/Fee-reimbursement from any department before Commencement of even semester examination, the candidate shall have to pay the fee prescribed by our Institution before appearing to the even semester examination every year.
8. If you have selected through KEA-UGET/KEA-PGCET and belongs to CAT-1 and for IIA, IIB, IIIA & IIIB are eligible for Fee-concession. For further details, you may log on to <http://karepass.cgg.gov.in>
9. There is also a provision for scholarship / financial aid from Government Department / Public Sectors / Pvt. Trusts/Agencies for Merit Cum Poorer section of students, the list is announced on the notice board. Eligible candidates can apply when the application is called for.
10. You are strongly advised and informed to see the Main and Departmental Notice Board regularly. Please note that late submission of Application with regards to Scholarship, Examination, Re-Registration etc., will result in losing the benefits which the candidate is eligible.

11. You are not allowed to use mobile inside the campus.
12. You are informed to come to college with decent dress. (Formal Dress) with Collared T-Shirts.
13. Keep your belongings safely. The college authorities are not responsible for any loss.
14. You should not indulge in any anti-social activities. You should not indulge in any ragging. You must abide by the disciplinary norms stipulated by the college. If you violate these instructions, the college authorities have the right to take suitable disciplinary action against you.
15. You are informed that you have to pay the Annual tuition fee every year within 15 days from the date of commencement of classes by logging in to the Unicare Portal or visit at [www.rrinstitutions.com](http://www.rrinstitutions.com) or as announced by the institution. If you do not pay the fees within the stipulated date, you will not be allowed to attend the classes. In this regard, parents are requested to confirm from the Accounts Section, well in time, whether the fees are paid in time by their wards. This is particularly important if the parents are sending the fees through their wards so that they can avoid inconvenience to attend the classes / semester end examination by their wards.
16. The newly admitted students are hereby informed to submit the anti-ragging Affidavit undertaking by logging in to [www.antiragging.in](http://www.antiragging.in) and duly filling the application and submitting the same.
17. In case the student discontinues the course, at any time AFTER the LAST DATE of admissions, the student will have to pay the fees for the remaining years of study and then obtain the original documents.
